SUBJECT: Appointment of Members to the Workforce Investment Board

Recommendation(s):

That the Board of Supervisors:

1. Approve the appointment and reappointment of the individuals listed to serve on the Workforce Investment Board for a term outlined on the attached roster.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 5. Maintain and Enhance the Quality of Life for All Residents.

Executive Summary and Discussion:

The Santa Barbara County Workforce Investment Board (WIB) is mandated by Public Law 105-220. The WIB currently oversees the workforce development strategic initiatives, policies, and performance outcomes for Santa Barbara County. The local WIB negotiates performance levels with the state, supports ongoing economic development efforts, facilitates local innovation for employer and job seeker services, provides advocacy for employment related issues, and develops an annual recommended budget. In addition, the WIB provides guidance and oversight for the local Workforce Resource Center system services and activities.

In Santa Barbara County, the WIB is working towards a system that meets the needs of both businesses and job seekers. The WIB currently has 16 members, including federally prescribed and locally added membership. The majority is to be held by private sector members. The Board of Supervisors appoints all members of the WIB which are recruited from local business organizations. The Workforce Investment Act states that the private sector members must serve in an executive capacity in their business.

Mandates and Service Levels:

The Workforce Investment Act requires that local Workforce Investment Boards meet certain membership composition requirements. These appointments are aligned with those requirements.
