#### **APAC CONTINUED ITEMS:**

1. 70-AP-022 **Azteca Properties** Santa Maria Case Number: NA

Planner: No Planner assigned

Consider the ongoing eligibility of agricultural preserve contract 70-AP-022 and its consistency with the Uniform Rules pursuant to Uniform Rules and any enforcement actions pursuant to Uniform Rule 6 following a change in ownership of the contract. The contract consists of Assessor's Parcel Numbers 117-160-050 (132.89 acres) and 117-160-048 (4.41 acres). The County of Santa Barbara acquired Assessor's Parcel Number 117-160-048 through a grant deed in 1973 as per recorded document #48648 in Book 2492, Page 1230 of Official Records, and is excluded from the Agricultural Preserve Program. The two contracts are no longer under common ownership and Assessor's Parcel Number 117-160-050 must now qualify individually for the program. The property is located in the Santa Maria area, Fifth Supervisorial District. (continued from 4-10-25, 6-12-25 and 8-14-25)

2. 74-AP-034 Just Over There, LLC Carpinteria

Consider the ongoing eligibility of agricultural preserve contract 74-AP-034B and its consistency with the Uniform Rules pursuant to Uniform Rule 6-2 following a change in ownership of the split contract. The contract originally included three Assessor's Parcel Numbers 004-002-004, 155-170-040, and 155-170-041. The latter parcel is now under contract 98-AP-012. Parcels 004-002-004 and 155-170-040 changed ownership on July 12, 2024, per document # 2024-020507. The property, which consists of 11.12 acres and comprises Assessor Parcel numbers 004-002-004 and 155-170-040, is located in the Carpinteria area, First Supervisorial District. Consider the request of Dave Cross-Fletcher-Cross agent for the owner, Azteca Properties, of Case Number 25AGP-00009 regarding AG preserve renewal contract and its consistency with the Uniform Rules and consider ongoing eligibility of the property as an agricultural preserve consistent with the Uniform Rules and any enforcement actions pursuant to Uniform Rule 6. The property is 132.89 Acres identified as Assessor's Parcel Number 117-160-050, zoned AG-II-40 with an AC Comprehensive Plan designation located at 1891 Main Street in the Santa Maria area, 5th Supervisorial District.
