- A. Accept the Notice of Completion for the FY 2010/2011 ADA Concrete Repairs in the Second Supervisorial District, and authorize Clerk to Record. The work was performed by the Contractor, G. Sosa Construction (a Santa Barbara County vendor), 400 E. Clark, Ste. #D, Santa Maria, CA 93456;
- B. Approve and authorize the Chair to execute the Statement of Final Quantities for the FY 2010/2011 ADA Concrete Repairs in the Second Supervisorial District for work performed and materials supplied by G. Sosa Construction in the amount of \$158,851.37.

Summary Text:

The project replaced 490 square yards of sidewalks, 200 linear feet of curb and gutter and installed 26 ADA compliant curb ramps.

The Director of Public Works accepted this project as complete on May 5, 2011. The project was completed on time and on budget.



Background:

The Board of Supervisors approved this project on June 15, 2010, as part of the Road Maintenance Annual Plan. One strategy the Department utilizes in its annual plan is the preventive maintenance program which is to repair hardscape, gutters spandrels, cross gutter sidewalks and installing ADA compliant curb ramps.

On June 15, 2010, your Board approved the Notice of Exemption pursuant to the County’s California Environmental Quality Act (CEQA) guidelines.

On March 1, 2011, your Board awarded the construction contract for this project to G. Sosa Construction.
