SUBJECT: State of California, 2002/2003 Exchange and State Match Program, Execute Agreement for the Exchange of Federal Highway Dollars-All Supervisorial Districts

Recommendation(s):

That the Board of Supervisors:

- A. Execute the agreement with State of California, Department of Transportation for the exchange of Federal Highway dollars for Non-Federal State Highway Account dollars, for Fiscal Year 2002/03 apportionments, in the amount of \$558,115.
- B. Authorize Staff to disperse these Regional Surface Transportation Program (RSTP) funds to the City of Buellton, the City of Guadalupe and the City of Solvang, in the amounts identified for FY 2002/2003 in the Federal Transportation Improvement Program (FTIP).

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

With the approval of the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991, Santa Barbara County was appropriated a certain sum of funds as determined by the Federal Government annually. These funds are shared by the County and Cities of the County as determined by guidelines adopted by the Santa

Barbara County Association of Governments (SBCAG). Furthermore, Streets and Highway Code Section 182.6 and 182.9 allow the exchange of these funds for Non-Federal State Highway Account funds.

This exchange is desirable as it gives the County the flexibility to use these funds for a wide range of transportation improvements; from local road improvements to other State or Federally funded projects. The Federal mandates associated with federal funds are not applicable to funds converted to State Highway Account dollars. Therefore, these funds can be used without federal restrictions. Your Board has approved similar exchange agreements in each of the last six fiscal years. With the execution of this agreement, the County can receive the FY 02/03 apportionment.

Mandates and Service Levels:

No change in programs or service level.

Fiscal and Facilities Impacts:

With the execution of this agreement, the County will receive \$558,115.00. These funds will be deposited in Budget 054, Fund 0015, Account 4320. Through this agreement the County is receiving and will disperse to to the City of Buellton, \$39,188, the City of Solvang, \$54,585 and the City of Guadalupe \$57,932.
