**RE:** HEARING - Consider recommendations regarding the Extension of Corizon Health, Inc. Medical Services Contract for Sheriff and Probation, as follows: (EST. TIME: 30 MIN.)

a) Approve an extension of the Corizon Health, Inc. contract for medical, mental health (Sheriff only), and pharmaceutical management services to Inmates and Youth at the Sheriff's Office facilities and Probation Department facilities for the period from July 1, 2015 through June 30, 2017 for a total cost not to exceed \$9,833,099.00 for the term of the extension; and

b) Determine that these activities are exempt from the California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15061 (b) (3).

**TO EXTEND CORRECTIONAL MEDICINE AGREEMENT**

**Effective July 1, 2015**

**THIS IS THE FIRST EXTENSION** (hereafter referred to as **First Extension**) to the 2013 Correctional Medicine Agreement (hereafter **Agreement**), by and between the County of Santa Barbara (COUNTY) and Corizon Health, Inc. (CONTRACTOR), for the provision of Medical Services at Santa Barbara County Jail and Probation facilities.

**WHEREAS**, the Agreement is effective through June 30, 2015; and

**WHEREAS**, the parties desire to extend the Agreement to extend the term for a one hundred twenty day period; and

**WHEREAS**, this First Extension incorporates the terms and conditions set forth in the 2013 Agreement, and are incorporated herein in full.


**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, and incorporating all terms and conditions set forth in the 2013 Agreement, the parties agree as follows:

1. **TERM.** The Agreement is hereby extended for a period of 120 days for the period of July 1, 2015 through October 31, 2015 and is approved and accepted by both parties.
2. **FINANCIAL.** The financial terms for the 2014-2015 fiscal year shall apply for the period of the 120 day extension.


