### **Recommendations:**

That the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District accept the Easement Deeds by authorizing the Clerk of Board to sign the Certificate of Acceptances from Antonio Ramasanta over portions of 22 and 29 West Cabrillo Blvd and 1, 17, and 29 State St., APNs 033-102-02, 033-102-15, 033-102-16 for the Lower Mission Creek Flood Control Project.

### Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with actions required by law or by routine business necessity.

### **Executive Summary and Discussion:**

The granting of these easements to Flood Control District is in anticipation of the Lower Mission Creek Flood Control Project. The proposed project is being cost shared and sponsored by the City of Santa Barbara, the Flood Control District, and the Army Corps of Engineers. The project requires the acquisition of real property for the channel improvements along lower Mission Creek. As properties or property interests become available, the Flood Control District is attempting to acquire the necessary property interests needed for construction and maintenance of the project.

As a condition of approval for the development plans for 29 State Street, the City of Santa Barbara required the owner of the property to grant the Flood Control District easements on portions of APNs 033-102-02, 033-102-15, and 033-102-16 for the Lower Mission Creek Project.
