

**RESOLUTION OF THE BOARD OF TRUSTEES
OF THE SANTA BARBARA COUNTY LAW LIBRARY**

Resolution to Amend Law Library Conflict-of-Interest Code

WHEREAS The Political Reform Act requires every local government agency to review its Conflict-of-Interest Code biennially, and

WHEREAS, the Santa Barbara County Law Library Conflict-of-Interest Code was last amended in January 1982, and

WHEREAS the Trustees approved an amendment to the Law Library Conflict-of-Interest Code that Judicial Trustees are not required to file a separate Statement of Economic Interest with the Santa Barbara County Clerk because the comprehensive Statement of Economic Interest that they file with the State is deemed adequate to comply with the requirements of the Political Reform Act and 2 California Code of Regulations, Section 18730,

NOW THEREFORE BE IT RESOLVED that the Conflict-of-Interest Code heretofore adopted by this Law Library be hereby amended by incorporating certain changes required by the State Code, and

BE IT FURTHER RESOLVED that the attached document is adopted as the Conflict-of-Interest Code of the Santa Barbara County Law Library Board of Trustees, as amended December 2, 2024.

THE Secretary of the Board of Trustees is directed to forward the original amended Conflict-of-Interest Code to the Board of Supervisors, County of Santa Barbara, for its approval, and to make and retain on file a copy of said Code.

REVISED CONFLICT-OF-INTEREST CODE
FOR THE
SANTA BARBARA COUNTY LAW LIBRARY

The Political Reform Act, Government Code Section 81000, et seq., requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation, 2 California Code of Regulations Section 18730, that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations, Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices A and B, in which members and employees are designated and disclosure categories are set forth, shall constitute the Conflict-of-Interest Code of the Santa Barbara County Law Library.

Individuals holding designated positions shall file a Statement of Economic Interest annually with the **Santa Barbara County Clerk**, who will make the statements available for public inspection and reproduction (Gov. Code Sec. 81008). Statements for all designated employees will be retained by the agency.

Judicial officers holding trustee positions on the Law Library Board, who file comprehensive Statements of Economic Interest (SEI) annually with the State for their judicial positions, are not required to file a separate SEI with the Santa Barbara County Clerk as their filing with the State is deemed adequate to comply with Law Library's Conflict-of-Interest Code.

Appendix B

DISCLOSURE CATEGORIES

Category 1. Interests in real property located within the jurisdiction or within two miles of the boundaries of the jurisdiction; and investments and business positions in business entities, and income, including loans, gifts, and travel payments, from all sources.

Category 2. Interests in real property located within the jurisdiction or within two miles of the boundaries of the jurisdiction.

Category 3. Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources that provide services, supplies, materials, machinery, or equipment of the type utilized by the agency.

Category 4. Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources that filed a claim against the agency during the previous two years or have a claim pending.

Category 5. Investments and business positions in business entities, and income from sources that manufacture, distribute, supply, or install computer hardware or software of the type utilized by the agency, as well as entities providing computer consultant services.
