SUBJECT:	Reallocation of Fiscal Year 2003/2004 Measure D Operations and Maintenance Funding from Metropolitan Transit District Shuttle to Transportation Improvements in the Second and Third Districts.

#### **Recommendation:**

That the Board of Supervisors amend the Measure 'D' Program of Projects for FY 2003/2004 to reallocate \$84,000 previously programmed for operations and maintenance costs associated with a shuttle operated by Santa Barbara Metropolitan Transit District (MTD), to the following projects in the 2<sup>nd</sup> and 3<sup>rd</sup> Supervisorial Districts:

- 1. Obern Trail Solar Bikepath Lighting;
- 2. Maria Ygnacio Bikepath Bridge Resurfacing;
- 3. Monte Vista School Neighborhood Traffic Calming Improvements;
- 4. Bus service for the Bridge House Shelter, Sweeney Road; and
- 5. Isla Vista Bus Stop Improvements.

## Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

#### **Executive Summary and Discussion:**

In 1999 MTD submitted a Congestion Mitigation Air Quality (CMAQ) grant that in part, secured funding to purchase electric shuttles to provide transit service in the Goleta Old Town Redevelopment Project Area.

In anticipation of the shuttles' arrival and commencement of the service, your Board each year has programmed approximately \$84,000 in Measure D funding (prior to Goleta's incorporation, the programmed amount was \$168,000). This money was to be used as the County's contribution to MTD for operations and maintenance costs associated with running the Old Town electric shuttles.

Start up for the proposed Old Town shuttle service did not occur during fiscal year 2003/2004.<sup>1</sup>

Therefore, staff requests the Board's consideration of the following proposed projects for the reallocation of approximately \$84,000 in Measure D funding:

- 1. Obern Trail Solar Bikepath Lighting;
- 2. Maria Ygnacio Bikepath Bridge Resurfacing;
- 3. Monte Vista School Neighborhood Traffic Calming Improvements;
- 4. Transit Service for the Bridge House Shelter, Sweeney Road; and
- 5. Isla Vista Bus Stop Improvements.
- 1. <u>Obern Trail Solar Bikepath Lighting: 2<sup>nd</sup> District</u>-- Forty-two (42) new solar powered lights were installed along the Obern Trail between Goleta Beach County Park and Walnut Lane in the unincorporated area of Goleta. The lights provide a safe environment for commuters and recreational users. Reprogrammed Measure D funding of \$22,000 will be used as the local match for \$163,000 in State Bicycle Transportation Account funding secured by Public Works.
- 2. <u>Maria Ygnacio Bikepath Bridge Resurfacing</u>: 2<sup>nd</sup> <u>District</u>-- The bridge is located immediately north of the intersection of the Maria Ygnacio and Obern Bikepaths. The bridge surface is deteriorated and will be replaced with durable planking made of recycled plastic lumber. Reprogrammed Measure D funding of \$5,000 will compliment \$5,000 in Coastal Resource Enhancement funds awarded by the Board of Supervisors this fiscal year.
- 3. <u>Monte Vista School Neighborhood Traffic Calming Improvements: 2<sup>nd</sup> District</u>-- Speed surveys in this neighborhood indicate excessive speed for a residential area. Eighty-five percent of motorists traveling along the residential street of Pueblo Ave. travel at 40 miles per hour. Staff is working with residents of the neighborhood to identify potential physical improvements to calm traffic in this area including completing missing gaps in sidewalks, signage, striping and speed humps. Reprogrammed Measure D funding totaling \$15,000 will be used to fund construction of these improvements.
- 4. <u>Transit Service for the Bridge House Shelter, Sweeney Road: 3<sup>rd</sup> District</u>-- This 56 bed shelter for homeless men, women and children is located in the unincorporated area just outside of the Lompoc City Limits. Bridge House clients will receive new bus service provided by COLT (City of Lompoc Transit) consisting of 3 morning trips and 3 evening trips each day. Measure D funding totaling \$16,000 will be used to fund service from January 1, 2005 through June 30, 2005. Assuming the service is adequately utilized by Bridge House clients, revenues to fund the service in fiscal year 2005-2006 will need to be determined.
- 5. <u>Isla Vista Bus Stop Improvements:</u> 3<sup>rd</sup> District-- Measure D funding totaling \$26,000 will be used to construct alternative transportation improvements vital to Isla Vista's ongoing revitalization efforts. The following lists specific improvements and material/labor costs:

- Los Carneros/El Colegio Inbound: \$13,000 for a shelter, bench, trash can and schedule information.
- El Colegio/Camino Corto Inbound: \$13,000 for a shelter, bench, trash can and schedule information.

#### Mandates and Service Levels:

No change in programs or service levels.

#### **Fiscal and Facilities Impacts:**

These projects will be funded with fiscal year 2003/2004 Measure 'D' revenues in the amount of \$84,000. Funding for these projects has been budgeted in Fund 0015, Org. Unit 0002, Program 2900, Department 054 and Account 7511.
