#### Summary Text:

The County of Santa Barbara entered into a contract with W.T. Thomson Construction on April 18, 2006 to remodel approximately 5,400sf of existing office space for the Treasurer-Tax Collector Department. Construction ran smoothly, and the remodel was completed on time and within budget. Notice of Completion will provide for release of retention. Background:

This remodel created space to facilitate the efficient and effective operation of the department by providing increased and appropriate-sized offices for managers and employees as outlined in the County

The work was completed on September 7, 2006 (with minor punch list items being completed on November 17, 2006) for a total contract amount of \$240,065.50, which is inclusive of the original contract amount of \$219,810 plus minor electrical and architectural revisions totaling \$20,255.50. Construction of the remodel ran smoothly and the project was finished on schedule. Approval of this Notice of Completion will provide for release of retention.
