Accept a thirty (30) foot wide offer of Public Road and Utility easement over Telephone Road as described in attached Exhibit "A" (easement description) and shown in attached Exhibit "B" (visual depiction).

Summary Text:

This easement is offered by Basin Investments, LLC, as a condition of Lot Line Adjustment 07LLA-00000-00001 (reduced copy attached). This Lot Line Adjustment is currently being processed through the Office of the County Surveyor. The acceptance of this offer will clarify the easement and supersede previous dedications but will not in any way change the physical roadway as it currently exists.

Background:

Telephone Road, north of Clark Avenue is a publicly maintained road within public road easement. Frequently, as in this case, it is desirable to require the applicant of a project to re-dedicate public road easement along the property boundary to clean-up and clarify the easement for future reference.
