GENERAL: CONTRACT ISSUED TO PROVIDE LABOR & MATERIALS TO PERFORM EMERGENCY REPAIRS AND INSTALL PROTECTIVE METHODS IN ACCORDANCE TO EMERGENCY PERMIT NO. G-4-17-0013 DATED FEBRUARY 14, 2017 AND ISSUED BY THE CALIFORNIA COASTAL COMMISSION ON FEBRUARY 16, 2017 AND ATTACHED PLACEMENT PLAN AND AND WORK AREA NOTED IN FIGURE 1. IN JANUARY AND FEBRUARY 2017, MAJOR STORMS AFFECTED SANTA BARBARA COUNTY CASUING HIGH SURF AND SHORELINE EROSION AT GOLETA BEACH REMOVING AN ESITMATED 30,000 CUBIC YARDS OF SAND AND CAUSING LANDWARD EROSION OF APPROXIMATELY 15 TO 20 FEET ALONG UP TO 447 FEET OF UNPROTECTED SHORELINE. EMERGENCY REPAIRS AND PROTECTIVE METHODS MUST BE PUT IN PLACE IN ORDER TO PREVENT FURTHER DAMAGE TO THE PARK INFRASTRUCTURE AND FACILITIES. ALL WORK TO BE BILLED ON A TIME & MATERIAL BASIS.

CONTRACT PERIOD: Start date, as directed. Termination date, as directed and NO LATER THAN 6/30/17.

LIMITATIONS: This contract can only authorize emergency expenditures up to \$175,000. Any additional expenditures would need to be approved by the Board of Supervisors.
