SUBJECT: No Parking Zones on Varley Street in the First Supervisorial District.

RECOMMENDATIONS:

C.A. Recommendation:

That the Board of Supervisors: Adopt a resolution establishing "No Parking" zones on Varley Street in the Summerland area

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendations are primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Varley Street is a residential road that extends westward from Valencia Road in the Summerland area.

The Summerland Elementary School is located on both the north and south sides of Varley Street to the west of Valencia Road. A street closure was constructed on Varley Street just west of Valencia Road to provide a safe walkway for students walking to and from campuses. With the closure in place, there is not adequate room for vehicles to turn around when accessing Varley Street from the west. After our investigation of this site, it was determined that creating a "No Parking" zone at this location (see vicinity map), would provide the proper turnaround space for those traveling on Varley Street. The Public Works Traffic Section has prepared the attached resolution to establish "No Parking" zones at the following locations:

- 1) On the south side of Varley Street from a point 214 feet west of the centerline of Valencia Road to a point 250 feet west of the centerline of Valencia Road.
- 2) On the north side of Varley Street from a point 214 feet west of the centerline of Valencia Road to a point 254 feet west of the centerline of Valencia Road.
