

LIBRARY ZONE NO. 1

Beginning at the point of intersection of the township line between Townships 7 and 8 North, S.B.B. and M. with the easterly boundary line of the County of Santa Barbara and running thence, westerly along said township line, to its intersection with the easterly line of Township 8 North, Range 29 West, S.B.B. and M.; thence southerly and westerly along the easterly and southerly lines of said township to its intersection with the center line of Happy Canyon Road; thence northwesterly along the center line of said Happy Canyon Road to and along the center line of Sunset Valley Road to the junction of Manzana and Davey Brown Creeks; thence northwesterly along the center line of said Manzana Creek to its junction with the Sisquoc River; thence northwesterly along the center line of said Sisquoc River to its intersection with the southeasterly line of Rancho Sisquoc; thence southwestwardly along said southeasterly line to its intersection with the center line of Zaca Creek; thence southwestwardly along the center line of said Zaca Creek to its intersection with the center line of Foxen Canyon Road; thence southerly along the center line of said Foxen Canyon Road to its intersection with the center line of State Highway No. 154; thence westerly along the center line of said Highway No. 154 to its intersection with the center line of Ballard Canyon Road; thence southerly along the center line of said Ballard Canyon Road and its prolongation southerly to its intersection with the center line of the Santa Ynez River; thence westerly along the center line of said river to its intersection with the center line of State Highway U.S. No. 101; thence southerly along said center line to its most southerly intersection with the center line of Gaviota Creek; thence southerly along the center line of said creek to its intersection with the mean high tide line of the Pacific Ocean; thence due south to a point on the Santa Barbara County boundary line; thence easterly along said Santa Barbara County line to the southeast corner of said Santa Barbara County; thence northerly along the easterly line of said Santa Barbara County to the point of beginning and including the islands of San Miguel, Santa Rosa, Santa Cruz and Santa Barbara.

LIBRARY ZONE NO. 2

Beginning at the point of intersection of the center line of San Antonio Creek with the mean high tide line of the Pacific Ocean and running thence easterly along the center line of said creek to its intersection with the southwesterly line of Rancho Todos Santos Y San Antonio; thence southeasterly along said southwesterly line to its intersection with the center line of San Antonio Road; thence easterly along the center line of said road to its intersection with the center line of State Highway No. 135; thence easterly along the center line of said State Highway No. 135 to its intersection with the center line of Den Street; thence southerly along the center line of Den Street to its intersection with the center line of Shaw Street; thence easterly along the center line of said Shaw Street to its intersection with the center line of St. Joseph Street; thence southerly along the center line of said St. Joseph Street to its intersection with the center line of Coiner Street; thence easterly along the center line of said Coiner Street to its intersection with the center line of Centennial Street, thence southerly along the center line of said Centennial Street to and along the center line of Drum Canyon Road to its intersection with the southerly line of Rancho Los Alamos; thence easterly along the southerly line of said southerly line of Rancho Los Alamos to its intersection with the westerly line of Rancho La Laguna; thence southerly along the westerly line of said Rancho La Laguna to the southwest corner thereof, being the northwest corner of Rancho San Carlos de Jonata; thence easterly along the northerly line of said Rancho San Carlos de Jonata to its intersection with the center line of Foxen Canyon Road; thence southerly along the center line of said Foxen Canyon Road to its intersection with the center line of State Highway No. 154; thence westerly along the center line of said Highway No. 154 to its intersection with the center line of Ballard Canyon Road; thence southerly along the center line of said Ballard Canyon Road and its prolongation southerly to its intersection with the center line of the Santa Ynez River; thence westerly along the center line of said river to its intersection with the center line of State Highway U.S. No. 101; thence southerly along said center line to its most southerly intersection with the center line of Gaviota Creek; thence southerly along the center line of said creek to its intersection with the mean high tide line of the Pacific Ocean; thence due south to a point on the Santa Barbara County boundary line; thence westerly and northerly along the boundary line of said County of Santa Barbara to a point due west from the point of beginning; thence east to the point of beginning.

LIBRARY ZONE NO. 3

Beginning at the point of intersection of the township line between Townships 7 and 8 North, S.B.B. and M. with the easterly boundary line of the County of Santa Barbara and running thence, westerly along said township line, to its intersection with the easterly line of Township 8 North, Range 29 West, S.B.B. and M.; thence southerly and westerly along the easterly and southerly lines of said township to its intersection with the center line of Happy Canyon Road; thence northwesterly along the center line of said Happy Canyon Road to and along the center line of Sunset Valley Road to the junction of Manzana and Davey Brown Creeks; thence northerwesterly along the center line of said Manzana Creek to its junction with the Sisquoc River; thence northwesterly along the center line of said Sisquoc River to its intersection with the southeasterly line of Rancho Sisquoc; thence southwesterly along said southeasterly line to its intersection with the center line of Zaca Creek; thence southwesterly along the center line of said Zaca Creek to its intersection with the center line of Foxen Canyon Road; thence southerly along the center line of said Foxen Canyon Road to its intersection with the northerly line of Rancho San Carlos de Jonata; thence westerly along the northerly line of said Rancho San Carlos de Jonata to and along the southerly and westerly lines of Rancho La Laguna to the southeast corner of Rancho Los Alamos; thence westerly along the southerly line of said Rancho Los Alamos to its intersection with the center line of Drum Canyon Road; thence northerly along the center line of said Drum Canyon Road to and along the center line of Centennial Street to its intersection with the center line of Coinar Street; thence westerly along the center line of said Coinar Street to its intersection with the center line of St. Joseph Street; thence northerly along the center line of said St. Joseph Street to its intersection with the center line of Shaw Street; thence westerly along the center line of said Shaw Street to its intersection with the center line of Den Street; thence northerly along the center line of said Den Street to its intersection with the center line of Ball Street; thence westerly along the center line of said Ball Street to and along State Highway No. 135 to its intersection with the center line of San Antonio Road; thence westerly along the center line of said San Antonio Road to its intersection with the southwesterly line of Rancho Todos Santos Y San Antonio; thence northwesterly along the southwesterly line of said Rancho Todos Santos Y San Antonio to its intersection with the center line of San Antonio Creek; thence westerly along the center line of said San Antonio Creek to its intersection with the mean high tide line of the Pacific Ocean; thence due west to a point on the Santa Barbara County line; thence in a general northerly, easterly and southerly direction along the boundary line of the County of Santa Barbara to the point of beginning.
