Today, you are to be commended for your support of the Santa Rita Valley Residents, by voicing your concerns re project problems and continuations. The Santa Rita Valley Ag project has truly been a revolving door to the House of Horrors. Even though I wasn't able to attend the entire hearing, I did listen to most of it and replayed/transcribed some of it. I understand that a final decision hasn't been reached but I *do hope* the Board finds to support the PC's decision and deny this project. As Marc Chytilo so aptly stated, "We hope this provides an opportunity to put a punctuation mark on this application so we can move on to more appropriate projects, in more appropriate locations for this industry."

Supervisor Lavagnino, I appreciated hearing you support Marc Chytilo's letter and your statements that concurred with him, "I'd just as soon not see this thing drag out so if we can come up with a date on the calendar, I think that would be helpful. From what I saw from the landowner, he does not appear to be too interested in negotiating so, I'd just as soon move this thing.... Quick." (Wow! Thank You, Steve!)

I also want to thank Supervisor Hartmann for her comments, which I believe reflect how we ALL feel: "The people in this community have been following this very closely. They've gotten geared-up and then it didn't happen. They'd gotten all geared-up again..., and then it didn't happen. So, I think its good government to give the people a sense of what the play work is so they don't have to keep following this beyond getting noticed. That would be my strong preference."
