At its March 13, 2008 meeting, Santa Barbara County's HOME Consortium Affordable Housing Loan Committee recommended the commitment of \$75,000 in federal HOME funds to Good Samaritan Shelters, Incorporated, for acquisition of real property located at 608 West Ocean Avenue in the City of Lompoc. Good Samaritan Shelters will provide a sixteen- (16) bed transitional housing facility on the site, as well as supportive services and case management for single women and women with children faced with drug- and/or alcohol addictions.
