SUBJECT: Tipping Fees for Cathode Ray Tubes and Other Electronic Waste

Recommendation(s):

That the Board of Supervisors:

Set a Public Hearing for November 22, 2005 for 10 minutes to consider adjustments in rates for accepting waste containing cathode ray tubes and other electronic waste, as follows:

a) Adopt a resolution (Exhibit 1), effective December 1, 2005, setting the attached fees for electronic waste collected at County facilities (Attachment A).

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

In accordance with Chapter 17 of the County Code, your Board shall adjust tipping fees at County facilities by resolution. Beginning in August 2001, the Department of Toxic Substance Control (DTSC) ruled that waste containing cathode ray tubes were hazardous and could no longer be landfilled. The primary sources of this waste are television screens and computer monitors. Lap top computers have recently been added to the list. To cover costs associated with handling this newly designated hazardous waste, your Board established a rate for cathode ray tubes at its facilities effective July 2002. Additionally, a rate for other electronic waste (not yet designated by DTSC as hazardous waste) was also established if a customer chose to bring the material in to be recycled.

In September 2003, the legislature approved SB20 which essentially allowed the collection of an up front fee from customers purchasing materials that contained cathode ray tubes (CRTs). The fees were effective January 2005. The fees collected through this program are distributed to collectors and recyclers of these materials to cover handling and processing costs. The County Public Works Department has applied for and been approved as a Collector of CRTs. As such we are eligible to receive a rebate of \$.20 per pound to cover our collection costs and no longer have to pay a disposal cost for this waste. Therefore, we are now able to reduce our rate charged to the customer from \$16.50 per unit to no charge.

The Department of Toxic Substance Control has issued a second mandate expanding the disposal prohibition to most other electronic waste. This mandate is scheduled to go into effect in February 2006. Currently, the rebate program has not been expanded to include this additional part of the electronic wastestream so the County will need to continue to charge for these materials. The County has received a grant from the California Integrated Waste Management Board to cover the cost to purchase equipment and develop and implement a countywide public outreach campaign explaining the new mandate. This grant will help defray future costs associated with the new mandate but does not cover the cost to dispose of the material. As such, Attachment A contains the new proposed rates for collecting these wastes at County facilities. The rates were developed based on actual costs to collect and dispose of this waste last fiscal year.

Mandates and Service Levels:

In response to mandates issued by the Department of Toxic Substance Control, the County is establishing programs to appropriately manage electronic waste. The attached rates have been developed to acknowledge receipt of funds through the SB20 rebate program as well as establishing rates for the future prohibition of electronic waste.

Fiscal and Facilities Impacts:

The attached rates will cover the costs to manage electronic waste. The rates for CRTs are decreasing and the other electronic rates are increasing based on actual costs incurred. In addition, more tiers were established to meet customer needs.
