### Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

#### **Executive Summary and Discussion:**

The project replaced the existing traffic signal and highway lighting system. In addition the project consisted of roadway and median modifications to construct two new left turn pockets (southbound Turnpike Road and eastbound Hollister Avenue) and upgraded the pedestrian ramps at all four corners. The project replaced the existing antiquated traffic signal to bring the entire intersection up to State Standards and ensure public safety. The new signal also has video detection. The added left turn pockets provide a dual turn pocket configuration, which allows more traffic to get thru the intersection within the same time to reduce congestion at the intersection.

The Director of Public Works accepted this project as complete on April 2, 2004. The project was completed on time and on budget.
