## Summary Text:

This item is on the agenda to approve the Memorandum of Understanding between the County and SBCAG to fund the construction phase of the Summerland Coastal Access Improvements Project and to approve the Plans and Specifications and award two separate construction contracts for:

a) Wallace Avenue Summerland Coastal Access Project; County Project 862418; State Project LPPSB1L-6090(088); First Supervisorial District to the lowest responsible bidder, Taylor Jane Construction LP.

b) Via Real Trail Enhancements Project; County Project 862417; State Project LPPSB1L-6090(088); First Supervisorial District to the lowest responsible bidder, Taylor Jane Construction LP.

On Thursday, May 5th, one (1) bid was opened for the Wallace Avenue Summerland Coastal Access Improvements Project. Taylor Jane Construction LP submitted the lowest responsible bid in the amount of \$3,616,610 which is less than 1% above the Engineer's Estimate. The Department analyzed the bid and determined the lowest bidder is responsible and responsive.

On Thursday, July 11th, four (4) bids were opened for the Via Real Trail Enhancements Project. Taylor Jane Construction LP submitted the lowest responsible bid in the amount of \$3,006,857 which is 13.5% below the Engineer's Estimate. The Department analyzed the bid and determined the lowest bidder is responsible and responsive.

Both Projects were bid in accordance with the Public Contract Code, which requires the award to go to the lowest responsible bidder. Public Works recommends awarding both of these contracts to Taylor Jane Construction LP.

### **Background:**

The County Board of Supervisors approved a Baseline Funding Agreement on August 14, 2018 with SBCAG, Caltrans, and the California Transportation Commission to receive funds awarded for the implementation of the Highway 101 Multimodal Corridor project from Cycle 1 of the Road Repair and Accountability Act of 2017 (Senate Bill 1 Funding). The MOU for these projects was approved by your Board on June 4, 2019 with Amendment No. 2 recently approved by your Board on November 29, 2022 (Attachment B). This MOU with SBCAG allows the County to be reimbursed for work performed to develop and construct these projects. Funding allocations and detailed responsibilities are included in the MOU.

The proposed Wallace Avenue Summerland Coastal Access Improvements Project is located on Wallace Avenue between Evans Avenue and Finney Street, and includes work within Lookout Park, which is a County-owned facility. The project area is located approximately 2-1/2 miles west of the City of Carpinteria, within the unincorporated community of Summerland.

These improvements to Wallace Avenue and Lookout Park were developed in coordination with Caltrans, Union Pacific Railroad, and the California Public Utility Commission, for the purpose of establishing an at-grade pedestrian crossing into Lookout Park. The projects will provide enhanced multi-modal transportation access to Lookout Park and associated coastal access resources through the increase in coastal parking and sidewalk along Wallace Avenue and pedestrian facility improvements within Lookout Park. With these improvements, coastal access multi-modal transportation within the Village of Summerland will be significantly improved.

The proposed Via Real Trail Enhancements Project is located on Via Real, between Greenwell Avenue and Padaro Lane. The project is located approximately 3 miles west of the City of Carpinteria, within the unincorporated community of Summerland. The improvements to Via Real will provide improved bicycle lanes, continuous sidewalk from Greenwell to Padaro lane along the southern side of Via Real, drainage improvements, reconstruction of the existing bus pocket, and improvements to equestrian trail conveyance

to Loon Point. These improvements to Via Real were developed in coordination with recent improvements to Caltrans highway 101 facilities within the Summerland corridor to provide enhanced multi-modal transportation access to coastal resources.

Prior to and during construction, the Department will implement a public outreach program to inform the public about the project construction schedule and traffic control impacts. During construction, while work is being performed that impacts traffic conveyance, the Contractor is permitted to utilize traffic control for one lane of alternating traffic control. Full width of the traveled way will be open to traffic when no active construction activities in the traveled way or within 6 feet of the traveled way, as well as each Friday after 3:00p.m. and on Saturdays, Sundays and holidays.

Narrative:

Approval of the MOU will provide the budget allocated to the construction of the Summerland Coastal Access Improvements Projects. With the approval of the MOU, a total of \$8,342,360 is committed to the Projects for construction phase of work. The total anticipated cost for the two construction contracts is \$7,143,441, with anticipated Construction Engineering (CE) costs of \$1,198,919. The funds made available by this MOU are allocated by Solutions for Congested Corridors (SCCP) program and Regional Surface Transportation Program (RSTP) funds administered by SBCAG. Through approval of the MOU, SBCAG would reimburse the County for 100% of all eligible expenses incurred. This project is budgeted in Fund 0017, Dept 054, Prog 2830, Org 0600, Projects 862417 (Via Real) and 862418 (Wallace Ave). Caltrans provides no additional funding for ongoing maintenance of these proposed improvements.
