## WITH REFERENCE TO THE FOLLOWING:

- A. On December 20, 1980, by Resolution No. 80-566, the Board of Supervisors adopted the Land Use Element of the Santa Barbara County Comprehensive Plan; and
- B. On January 3, 1983, by Ordinance 3347, the Board of Supervisors adopted the Santa Barbara County Inland Zoning Ordinance, Article III of Chapter 35 of the Santa Barbara County Code; and
- C. On July 22, 1997, the Board of Supervisors adopted the Orcutt Community Plan update to the Santa Barbara County Comprehensive Plan.
- D. On June 17, 2005, the Board of Supervisors directed Comprehensive Planning staff to develop a draft Streetscape Concept Plan for Old Town Orcutt.
- E. From July 2005 to June 2006, County staff has been working collaboratively with the Public Works Department and the 4<sup>th</sup> District Office and has also conducted individual meetings with representatives of three community organizations: Residents for Old Town Orcutt Preservation (ROTOP), Orcutt Area Advisory Group (OAAG), and the Old Town Orcutt Revitalization Association (OTORA). Two public workshops were held to develop the draft Streetscape Concept Plan. The draft plan was also reviewed by the North County BAR.
