SUBJECT: No Parking 7 AM to 3 PM School Days Only Zone on Dahlia Place in the Fourth Supervisorial District.

**RECOMMENDATIONS:**

That the Board of Supervisors adopt a resolution establishing a "No Parking 7 AM to 3 PM School Days Only" zone on Dahlia Place in the Orcutt area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Dahlia Place is a residential street in the Orcutt area. Alice Shaw School is located at the corner of Hillview Road and Dahlia Place. Currently, the school has a total of six buses that pick up and drop off each day. Four of their buses use the parking lot, while the other two park on Dahlia Place. The school's parking lot is not large enough to accommodate all six buses at the same time. The principal has requested a bus-loading zone to be established on Dahlia Place near Loch Lomond Drive. Based on staff's investigation of the situation, it was determined that a bus-loading zone would be appropriate. The Public Works Traffic Section has prepared the attached resolution to establish a "No Parking 7 AM to 3 PM School Days only" zone at the following location:

- On the north side of Dahlia Place, from a point 21 feet east of the centerline of Loch Lomond Drive to a point 81 feet west of the centerline of Loch Lomond Drive.
