SUBJECT: Streetscape Improvements on the Southern Portion of the Embarcadero Loop in the Isla Vista Area of the Third Supervisorial District; S.B. County Project No. 863032

Recommendation(s):

That the Board of Supervisors:

- A. Accept Notice of Completion for work performed by the Contractor, Mendez Concrete, Inc. (Not a Local Vendor), 1210 E. Santa Paula St., Santa Paula, CA, 93060, and authorize Clerk to record.
- B. Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, in the amount of \$95,960.06.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project located on the Embarcadero Loop, south of Pardall Road, was the first phase of an overall downtown streetscape improvement project for Isla Vista. During this project 497.6 linear feet of additional sidewalk was laid; improvements were made at the intersection of Embarcadero Del Mar and Seville and at several curb ramps; twenty-six (26) new trees were planted and tree grates, frames and guards were also installed with each tree.

This project is included in the proposed Isla Vista Master Plan.

The Director of Public Works accepted this project as complete on April 18, 2005. The project was completed on time and on budget.

Fiscal and Facilities Impacts:

This project was funded by \$10,000 of Measure “D” funds, and the remaining balance was funded by the following sources: Redevelopment Agency, County Service Area 31, and Road Designation (LRDP) funds. Measure “D” funds have been budgeted in Department 054, Fund 0015, Program 2900, Org 0002, and Account 7511. The remaining funds have been budgeted in Department 054, Fund 0015, Program 2900, Org 0002, and Account 7510.

Mandates and Service Levels:
