Recommendation: That the Park Commission receive a presentation on parking fees at 7 beach access points and other County park facilities, hear and consider all public comment, and discuss the following: a) Should the County consider parking fees at all County parks or only the seven beach locations? b) Should the County consider tiered parking fees or a flat rate? c) What should the parking fees be? d) How much should be charged for citations?

ACTION: The Park Commission received a presentation on proposed beach parking fees and listened to public testimony.

PUBLIC COMMENT:

Andy Seyboll was concerned that if a fee was imposed Alan Road parking for the neighborhood would get worse. The County should work with the City to create a plan that limits parking in the neighborhood or requires a resident parking pass. Robert Rodd was opposed to paid parking at the beaches. Shelby Sim, representing the Goleta Valley Chamber of Commerce was opposed to beach parking fees. Jeff Melnik was opposed to beach parking fees at Lookout Park in Summerland. Due to the Lily Avenue improvements, Summerland will be losing parking spaces. Skona Brittain said many people cannot afford to do quick beach visits and asked if an annual pass would be considered. Gilbert Loustalot was opposed to beach parking fees. Alan Howard was opposed to beach parking fees. He suggested including park maintenance in concession contracts and using volunteers. Tim Mahoney, representing Southern California Gas Company, was opposed to beach parking fees. He asked if utility or service trucks would be exempt from paying a fee when coming to work at a park. He asked to consider an annual pass. Richard Rojas asked if staff was being proactive with the California Coastal Commission. He also asked if there would be special passes for seniors and special needs citizens. Ted Quackenbush was opposed to beach parking fees. Beach access is limited and decreasing. The surrounding neighborhoods would be impacted greatly. Everett Lipman, representing Surfrider, was strongly opposed to beach parking fees. Scott Bull, representing Surfrider, was opposed to beach parking fees and is concerned with the negative impacts it will have on the surrounding neighborhoods. Adam White, owner of the Boathouse Restaurant at Arroyo Burro Beach, was concerned about the impact beach parking fees would have on his business. Tony de Groot was opposed to beach parking fees, especially at Lookout Park and Rincon Beach Park. Charlie Kelly was opposed to beach parking fees. Christine Fancher was opposed to beach parking fees and expressed that having these fees imposed would hurt low income families. Ed de la Torre, representing the Friends of Goleta Beach, was opposed to beach parking fees and expressed his concern for special needs access. David Hardy, owner of the Beachside Bar and Café at Goleta Beach, was opposed to beach parking fees and expressed his concern for his business. Jim Brinson was opposed to parking fees and expressed his concern for the restaurants.

a) Should the County consider parking fees at the seven beach locations?

- Impact on our beach restaurants

Commissioner Perkins moved, seconded by Commissioner Farina and carried by a vote of 5-0 to recommend that the Board of Supervisors forward these items for consideration to the Park Commission after their decision has been made.

PUBLIC COMMENT: Tyler Tomblin was opposed to beach parking fees. Low income families and the underprivileged would not be able to afford to go to the beach. Michael Morse feels the beach is public land and is part of the Santa Barbara Community experience. Jeff Parker frequents Guadalupe Dunes and a fee would stop him from visiting his favorite beach. Josh Rosenkrantz was concerned about the impacts to low income people, double taxation, surrounding neighborhoods, and Santa Barbara as a special place. Gusto Christopher represented the youth of Santa Barbara and was against parking fees. Stacy Christopher believed this is an unfair taxation and asked where will families get the money to go to the beach. The County needs to find another solution. Tony de Groot was concerned about struggling families. Gill Kaufman was opposed to parking fees.
