## WITH REFERENCE TO THE FOLLOWING:

- A. Whereas, the property identified as Assessor's Parcel Number (APN) 141-250-036 was under preserve 06AGP-00000-00009, and a Notice of Nonrenewal was recorded by the property owner on October 29, 2020 as instrument number 2020-0065057;
- B. Whereas, the new preserve created by this Resolution consists of 103.72 acres southeast of the intersection of Happy Canyon Road and Alisos Avenue, in the Santa Ynez Area, Third Supervisorial District (APN 141-250-036);
- C. Whereas, the new preserve area was previously covered under preserve 06AGP-00000-00009;
- D. Whereas, this matter was considered by the County's Agricultural Preserve Advisory Committee on August 10, 2023, and this preserve is being created following a hearing of the Board of Supervisors on December 5, 2023; and
- E. Whereas, notice of these actions have been provided as required by law.

## IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitations are true and correct.
- 2. The Board of Supervisors finds that the creation of the Stagliano Vineyard Agricultural Preserve is consistent with the County's Comprehensive Plan.
- 3. Pursuant to the California Land Conservation Act of 1965 (the Williamson Act) (Government Code Sections 51200 et seq.), the Stagliano Vineyard Agricultural Preserve (23AGP-00001) is hereby established as an Agricultural Preserve in the County of Santa Barbara, and a contract for that purpose is hereby entered into.
- 4. A map of the preserve is filed in the Office of the Santa Barbara County Surveyor, and the preserve land is described in Exhibit "A" attached to the Short Form Land Conservation Contract.
- 5. This agricultural preserve shall be administered pursuant to the California Land Conservation Act of 1965 and the Uniform Rules for Agricultural Preserves and Farmland Security Zones adopted by this Board pursuant to said Act.
- 6. Pursuant to Government Code §51254, the contract 06AGP-00000-00009 is hereby rescinded and replaced by contract 23AGP-00001.
- 7. The Clerk of the Board shall endorse the fact of this creation and contract execution and the date thereof on said Surveyor's map and shall record this Short Form Land Conservation Contract (Short Form Contract) with legal description and Surveyor's Map attached, at the Office of the Santa Barbara County Recorder no later than December 31, 2023. In addition, the Clerk of the Board shall forward to the following interested parties copies of documents as follows:
  - i. To the County Recorder, a copy of the Surveyor's map;
  - ii. To the property owner, a duplicate original copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;
  - iii. To the Planning and Development Department, a conformed copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;

- iv. To the Assessor, a certified copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map; and
- v. To the Surveyor, a recorded copy of the Short Form Contract.
- 8. The property owner involved is The Stagliano Vineyard, LLC, 2610 Roundup Road, Santa Ynez, CA 93460
- 9. The Chairperson and the Clerk of the Board are hereby authorized and directed to sign and certify all maps, documents and other materials in accordance with this resolution to reflect the above described action by the Board of Supervisors.
