WHEREAS, Troy Carpenter retired from County service on Thursday, March 31, 2022, having faithfully served the Santa Barbara County Sheriff's Office for over twenty five years, during which he served as a Deputy Sheriff, Field Training Officer, New Cuyama Resident Deputy, and member of the Sheriff's Bomb Squad.

WHEREAS, Troy Carpenter started his career in law enforcement as a Reserve Deputy Sheriff with Santa Barbara County on October 24, 1996. He became a full-time Deputy Sheriff on June 26, 2000 and was assigned to patrol in South County Operations Division. He was later assigned to patrol in North County Operations Division. On February 13, 2006, Troy was assigned to New Cuyama as a Resident Deputy where he faithfully served the residents and visitors of this community until his retirement.

WHEREAS, Troy Carpenter dutifully served his country for 23 years as an active and reserve member of the Army National Guard, and retired as a Lieutenant Colonel.

WHEREAS, Troy Carpenter provided the employees of the Sheriff's Office with an exemplary work ethic and commitment to duty throughout his many years of service; and

WHEREAS, Troy Carpenter provided the residents of Santa Barbara County an extraordinary level of care and compassion while dedicating his life to the pursuit of justice; and

WHEREAS, Troy Carpenter's knowledge, skills and experience contributed greatly to the overall professionalism and the goals of the Santa Barbara County Sheriff's Office, as well as the objectives of the County.
