- 1. I want SB Sheriff to be transparent and accountable to Attorney General. Of the 98 transfers reported in the 2018 TRUTH Act Form, 0 were reported by the Sheriff's Office.
- 2. The SB Sheriff should not require ICE notifications for every person, conflate ICE notifications and transfers, or allow deputies to wait extra time if ICE is running late (an ICE detainer).
- 3. The SB Sheriff's office needs to stop sharing release information to ICE and should not allow a transfer to ICE.

These immigrants that have been deported because of the coordination with SB Sheriff are members of our community that we have lost. They are people that we live and work with. They are the ones growing our food and ensuring our critical infrastructure functions. It is wrong for us to speak of our support for our immigrant community while allowing these transfers and coordination to happen in our very backyard. We must stop this.

Dear County Board of Supervisors,

I encourage you to use with your budget priorities and funding capabiltiies to withdraw support for Sheriff's Department activities that are out of step with broad community values, and recent compelling initiatives for positive change. In particular, the Sheriff's Department expends our County's money to deploy officers' time and effort to notify ICE regarding undocumented persons detained in the County jail, and spends public funds to allow or require deputies to wait extra time before releasing undocumented jail inmates in a timely way if ICE representatives are running late and seek to detain them. These activities are outside the scope of the Sheriff's public safety role for our County and should be defunded by reducing County funds currently spent to staff such activities.

The policy of notifying ICE of detainees' releases and coordinating with ICE actually undermines trust in our Latinx community. Many undocumented people are acquaintances and/or family of people who are lawful citizens. What the Sheriff's office is doing undermines the community's sense of trust about his office and law enforcement generally. Then, when someone from our Latinx community is a victim of crime, there is be less likelihood of calling the Sheriff's office for help. As a result, perpetrators of crime against this large swath of our community tend to go unchecked because people are fearful to get the police involved. This is the exact opposite of what the Sheriff's office and other policing agencies should want to see. The Sheriff's misguided ICE relationship is undermining his central public safety role, not improving it.

I am writing to voice my concerns, as a resident of Santa Barbara, regarding local collaboration with Immigration and Customs Enforcement (ICE), especially moving forward in the current climate of COVID-19 and associated challenges.

I urge you to **demand transparency from the Sheriff's Office** in order to hold it accountable to the Attorney General. Specifically, the Sheriff's Office should not require ICE notifications for every person, nor should it conflate ICE notifications and transfers. Immigrants are not a monolithic threat to our society. Rather, immigrants are the fabric of our country, and make vital contributions to our local community. It's time we start respecting them by taking actions like the ones I've outlined above.
