Dear County Supervisors,

I am writing to ask that you accept the California Coastal Commission recommendations for amendments to the Eastern Goleta Valley Community Plan.

First and foremost, it provides habitat to many native species, including White Tailed Kites, the Burrowing Owl, multiple hawk species, coyote, and foxes.

Secondly, this open space is a popular recreation area for hikers, bikers, birders, surfers, swimmers, beach walkers, and more.

Third, it is unique in providing bluff access to people who are unable to climb or descend hills. To reach the Ellwood Bluffs in Goleta, you need to be able to manage small hills. To hike the popular front country trails (Cold Springs, Tunnel Road, etc.), one also needs to be able to manage hills. As someone with a muscle disease and arthritis, I know that More Mesa is one of only two natural places I can walk when I am not in my best health. (Los Carneros is the other one.) Ten years ago, when I first developed my muscle disease, I would walk twice a week on More Mesa with a friend. I am now lucky to live by More Mesa, and my whole family enjoys the open space. My husband loves his beach walks, my daughter jogs there, my son bikes there, and I walk along the bluffs. We encounter many visitors every time we go out there.

Please protect this valuable natural resource, and the animals that live there.

As long-time residents of Eastern Goleta Valley, our family has benefited from the open spaces that punctuate residential and commercial development in the area. Besides helping to counteract pollution from the freeway, several arterial roads, the airport, and the railroad, these spaces open up mountain views and contribute to a relaxed ambience. Because dense development has been controlled, local streets are safe and pleasant for recreational use like dog- or child-walking, and in places they form part of the heavily traveled bicycle trail heading west from downtown Santa Barbara as far as UCSB.

The cliff-top expanse of More Mesa, in particular, contributes recreational amenities for residents, providing pedestrian access to the beach and a semi-wilderness experience for young people, who can explore safely on bikes, horseback, or on foot. Otherwise, this part of Eastern Goleta Valley lacks recreational park space. An important feature of More Mesa is its role in conserving natural habitat for animals and birds, as well as vernal pools and other habitat for native plant life.

Thank you for considering our appeal to recognize and support the special significance of More Mesa to its immediate location as well as to the County as a whole.
