AMENDMENT TO AGREEMENT FOR SERVICES BETWEEN
THE COUNTY OF SANTA BARBARA AND
THE SANTA BARBARA COUNTY ASSOCIATION OF GOVERNMENTS

THIS AMENDMENT (hereafter Amendment) is made by and between the County of Santa Barbara (hereafter COUNTY) and the Santa Barbara County Association of Governments (hereafter SBCAG) to amend that certain Agreement for Services (hereafter Agreement) entered into on October 18, 1990 wherein SBCAG and COUNTY agreed, inter alia, that SBCAG would provide certain services and COUNTY would pay for the cost of said services and

WHEREAS, the parties wish to delete certain services and to diminish the compensation for services.

NOW, THEREFORE THE PARTIES agree as follows:

1. Section 1 is deleted in its entirety and the following is added in its place:

1. For the period of the Agreement, SBCAG shall provide the following services:

- a) The operation, staffing, administration, support and supplies of the Airport Land Use Commission;
- b) The development, presentation and public hearings associated with development and maintenance of airport land use planning projects.

For and in consideration of such services, COUNTY agrees to pay fifteen thousand dollars (\$15,000) in fiscal year 1993-94, such amount to be paid through the budget of a department to be identified by COUNTY. For future fiscal years, the amount payable shall be adjusted as needed and approved by mutual consent of the parties.

2. Section 3 is deleted in its entirety.

3. Section 10 is deleted in its entirety.

4. All other terms and conditions remain in full force and effect.
