SUBJECT: Allocation of \$66,377 from South Coast West Quimby Fee Trust Fund for Rhoads Open Space Recreation Improvements; Second Supervisorial District

Recommendation:

That the Board of Supervisors approve a budget revision to appropriate \$66,377 from the South Coast West Quimby Fee Trust Fund (#1400) for the installation of a playground, walkway, picnic table, benches, and a drinking fountain at Rhoads Open Space in the Goleta area.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 5 – A High Quality of Life for All Residents.

Executive Summary and Discussion:

Rhoads Open Space, which is partially developed with an irrigated lawn, is approximately 2.46 acres in size and is located in the unincorporated area of Goleta. Community meetings, sponsored by County Supervisor Susan Rose, have been held, at which requests from the public were made for additional improvements to the open space. Improvements requested included play equipment and swings for young children, benches, picnic tables, a drinking fountain, and additional landscaping. An Americans with Disabilities Act (ADA)-approved walkway is also required for access to the new playground.

The requested allocation of \$66,377 from the South Coast West Quimby Fee Trust Fund will provide funds to complete the first phase of the project, which includes the installation of the playground, the ADA walkway, four benches, a picnic table, and a drinking fountain. Additional, second phase improvements, which will include the installation of a new swing set, will be funded by community fundraising. These improvements will assist in meeting recreational needs within this neighborhood area.

Mandates and Service Levels:

There are no mandates or changes in service levels.

Fiscal and Facilities Impacts:

The funding requested for this project (\$66,377) is available in the South Coast West Quimby Fee Trust Fund (#1400). Use of this Trust Fund is restricted to development of park or recreational facilities within the South Coast West Quimby Demand Area. The current balance in the South Coast West Quimby Fee Fund is \$185,437. Approval of this funding request will reduce the Trust Fund balance to \$119,060.

There is no impact to facilities that will result in additional staffing or significant ongoing costs for the Parks Department.
