Executive Summary and Discussion: The construction project under contract with Schock-Hanly Corporation was completed on October 24, 2003 and involved the construction of 180 linear feet of vegetated gabions wall along the Water Plant building. The lake embankment adjacent to the water treatment plant was severely eroded during the 2001 storms and was declared eligible for funding by State of California Office of Emergency Services.

Mandates and Service Levels: No mandates or impact to service levels with this action.

Fiscal and Facilities Impacts: This project was funded from the State of California Office of Emergency Services Natural Disaster Assistance Funds, project account 8484 and from U.S. Bureau of Reclamation Grant, project account 8513.
