This project was last considered by the Board on December 6, 2022 (item A-9 on the Administrative Agenda). At that hearing, the Board continued the item to December 13, 2022, by a vote of 5 to 0. Staff has prepared a revised Agricultural Preserve Resolution (Attachment 1 to this memorandum), which reflects the change in the date of the Board of Supervisors' decision.

Recommended Action

On December 13, 2022, your Board's action should include the following:

- a) Adopt a resolution creating Agricultural Preserve Contract No. 20AGP-00000-00020 (Attachment 1 to this memorandum) consisting of 158.91 acres located at 4399 Dominion Road in the Santa Maria area (APNs 129-170-027 and 129-170-028);
- Approve and authorize the Chair to execute Agricultural Preserve Contract No. 20AGP-00000-000020 (Attachment 2 to the Board Letter prepared for the December 6, 2022, Board of Supervisors hearing);
- c) Authorize recordation by the Clerk of the Board; and,
- d) Determine that the project is exempt from environmental review pursuant to CEQA Guidelines Section 15317, as specified in Attachment 5 of the Board Letter prepared for the December 6, 2022, Board of Supervisors hearing.

WITH REFERENCE TO THE FOLLOWING:

- A. Whereas, the new preserve created by this Resolution consists of 158.91 acres located at 4399 Dominion Road in the Santa Maria area (APNs 129-170-027 and 129-170-028), Fourth Supervisorial District;
- B. Whereas, this matter was considered by the County's Agricultural Preserve Advisory Committee on October 7, 2022, and this preserve is being created following a hearing of the Board of Supervisors on December 13, 2022; and
- C. Whereas, notice of these actions have been provided as required by law.

IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitations are true and correct.
- 2. The Board of Supervisors finds that the creation of the GSR, LLC Agricultural Preserve (20AGP-00000-00020) is consistent with the County's Comprehensive Plan.
- 3. Pursuant to the California Land Conservation Act of 1965 (the Williamson Act) (Government Code Sections 51200 et seq.), the GSR, LLC Agricultural Preserve (20AGP-00000-00020) is hereby established as an Agricultural Preserve in the County of Santa Barbara, and a contract for that purpose is hereby entered into.
- 4. A map of the preserve is filed in the Office of the Santa Barbara County Surveyor, and the preserve land is described in Exhibit "A" attached to the Short Form Land Conservation Contract.
- 5. This agricultural preserve shall be administered pursuant to the California Land Conservation Act of 1965 and the Uniform Rules for Agricultural Preserves and Farmland Security Zones adopted by this Board pursuant to said Act.
- 6. The Clerk of the Board shall endorse the fact of this creation and contract execution and the date thereof on said Surveyor map and shall record this Short Form Land Conservation Contract (Short Form Contract) with description attached, at the Office of the Santa Barbara County Recorder no later than December 31, 2022. In addition, the Clerk of the Board shall forward to the following interested parties copies of documents as follows:
 - i. To the County Recorder, a copy of the Surveyor's map;
 - ii. To the property owners, a duplicate original copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;
 - iii. To the Planning and Development Department, a conformed copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;
 - iv. To the Assessor, a certified copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map; and
 - v. To the Surveyor, a certified copy of the Short Form Contract.
- 7. The property owner involved is GSR, LLC, 45 Rockefeller Plaza, Suite 2410, New York, NY 10111-2493
- 8. The Chairperson and the Clerk of the Board are hereby authorized and directed to sign and certify all maps, documents and other materials in accordance with this resolution to reflect the above described action by the Board of Supervisors.
