SUBJECT: Donation of Kids 1st Foundation Funds To Sheriff's Department

Recommendation(s):

That the Board of Supervisors accept a donation of \$75,000 from the Kids 1st Foundation for use by the Sheriff's Department to fund an Explorer program.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

The Kids 1st Foundation is a California Non-Profit Public Benefit Corporation organized for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The purpose of the Kids 1st Foundation is to raise funds to benefit the children of Santa Barbara County.

On August 14th, the Kids 1st Foundation presented to the Sheriff a check for \$75,000. The donated funds are earmarked to fund the Explorer program sponsored by the Sheriff's Department. The program designed to educate and involve youth in law enforcement as an avenue for mutual understanding and possible career opportunities. The department considers the Explorer program another in a series of recruitment tools. Expenditures include uniforms, training material academies and competitions. Any funds not expended in the current fiscal year will be designated in the Sheriff's Donation designation, Fund 1565 for use in future fiscal years.

Mandates and Service Levels:

No changes in programs, mandates or service levels will occur with the receipt of these funds. This donation complies with the policy on donations and gifts adopted by the Board on 4-11-2006.

Fiscal and Facilities Impacts:

This donation was anticipated in the FY2006-07 Adopted Budget as revenue with offsetting expenditures under a single project code 2460. Therefore no budget revision is necessary. The check was deposited with the Treasurer on August 15, 2006. Any funds not expended in the current fiscal year will be designated in the Sheriff's Donation designation, Fund 1565 for use in future fiscal years.
