

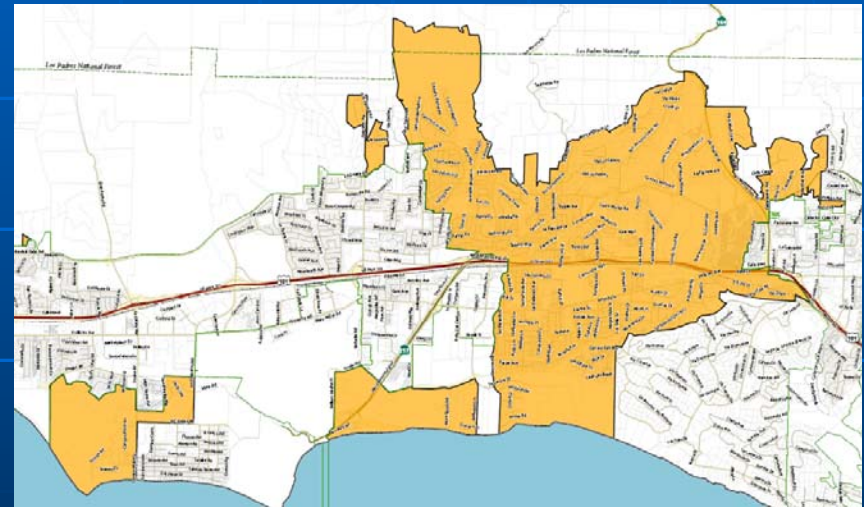

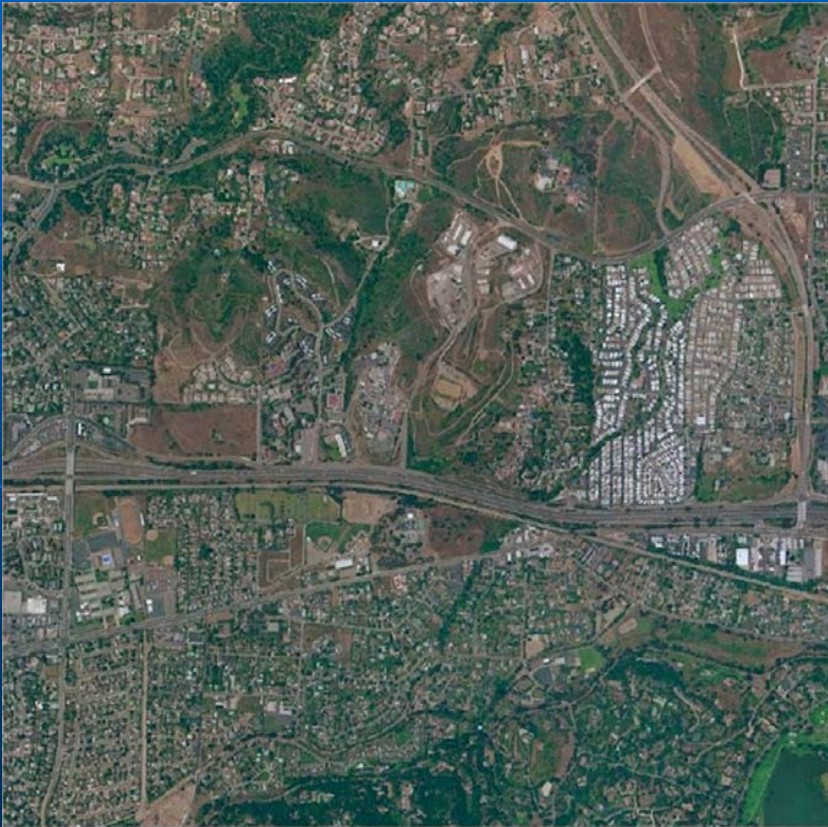


Goleta Valley CSA 3

- Created in 1963
- Streetlighting for unincorporated Goleta and Santa Barbara (19% of budget)
- Also funds open space and park maintenance and library services
- No change to rate of \$8 per year
