Authorize the Purchasing Manager to issue purchase orders, without a competitive bid, for Paragard Direct in the amount of \$150,000 per fiscal year; and Thera Com, Inc. in the amount of \$150,000 per fiscal year for pharmaceuticals over the two-year period of Fiscal Years 2008-09 and 2009-10. Neither vendor is a local vendor.

Summary

County Code Section 2-39 states that the Purchasing Agent is obliged to purchase all materials, supplies, furnishings and equipment by using a formal competitive bidding process, unless the Board of Supervisors has waived competition under a particular set of circumstances. For the sake of expediency, and due to "limitations in source or supply" pursuant to County Code Section 2-39, PHD is requesting your Board waive the requirement for a competitive bid for the purchase of certain pharmaceuticals. The County Purchasing Department recommends that bid waiver requests be made for each applicable fiscal year. This bid waiver request is for FY 2008-09 and FY 2009-10.

On June 03, 2008 your Board authorized bid waivers for FY 2007-08, 2008-09 and 2009-10 for several vendors. On that date Paragard Direct and Thera Com, Inc. were granted bid waivers in the amounts of \$70,000 and \$50,000 respectively. Usage of the products exceeded our estimates in Fiscal Year 2008-09 and the PHD is now requesting your Board to grant bid wavers in the amount of \$150,000 each for Paragard Direct and Thera Com, Inc. through Fiscal Year 2009-10.

Paragard Direct and Thera Com, Inc. are the only two manufacturers of intrauterine devices in the United States. The request for, and prescribing of, these birth control devices for the Public Health Department patients has increased significantly.
