FIRST AMENDMENT
Effective July 1, 2013

THIS IS THE FIRST AMENDMENT (hereafter referred to as First Amendment) to the Agreement for STEMI Receiving Center Designation (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and Santa Barbara Cottage Hospital (hereafter HOSPITAL).

WHEREAS, the Agreement is effective through June 30, 2013; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, this First Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Definitions.** Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
2. **Amendments.**
 - a. The Agreement is amended as follows:
 4. **TERM.** The ~~initial~~ term of this Agreement shall be for the period of July 1, 2010 **2013** through June 30, 2014 **2016**. This Agreement shall ~~renew automatically from year to year each July 1, for an additional two years unless cancelled by either party pursuant to Section 14 of this Agreement.~~
 5. **FEES.** HOSPITAL agrees to pay COUNTY for services provided under the terms of this Agreement: ~~\$15,000 for the initial services provided (fiscal year 2010-11) by the COUNTY for establishing the STEMI program and \$10,000~~ **\$15,000** annually thereafter, for maintaining the STEMI program. This annual service charge shall be paid in full by July 15th of each year of this Agreement, beginning July 15, 2014 **2013**. The ~~initial payment of \$15,000 shall be due upon execution of this Agreement.~~
3. **Counterparts.** This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
