

AMENDMENT TO AGREEMENT FOR SOLID WASTE COMMUNITY PROGRAMS
AND HOUSEHOLD HAZARDOUS WASTE DROP-OFF BETWEEN THE CITY OF
GOLETA AND COUNTY OF SANTA BARBARA

CITY AGREEMENT NO. _____

This Amendment (“AMENDMENT”) modifies the attached CONTRACT effective July 26, 2005, between the City of Goleta (“CITY”) and County of Santa Barbara (“COUNTY”) as follows:

Recitals

- A. The CITY and COUNTY entered a contract for the COUNTY to provide select solid waste Community Program and Regional Planning Services to the CITY and its residents; and
- B. The COUNTY also processes all residential commingled recyclables collected by the CITY’s solid waste collectors; and
- C. The CITY has requested that they share in the costs and revenues associated with the handling, processing, and marketing of the commingled recyclables originating from the City of Goleta; and
- D. The COUNTY is willing to share in the costs and revenues associated with this program, upon the terms and conditions hereinafter set forth.

Terms and Conditions

1. **Section 10. Billing and Payment.** The following paragraph will be inserted at the end of this section:

“Beginning July 1, 2007, net return from the processing and sale of the recyclable materials collected in the City of Goleta and delivered to the South Coast Recycling & Transfer Station will be deducted from or added to community program costs. Net return will be calculated based on the actual revenues and costs per ton associated with the management of the recyclables from the prior fiscal year multiplied by the tons of recyclables delivered to the South Coast Recycling & Transfer Station originating from the City of Goleta. Management costs include handling, storage, transportation, processing and disposal of residual. Commodity return will be calculated and mutually agreed upon by March of each year for the following fiscal year. Return deductions or additions will be itemized in the invoices submitted to the City.”

2. **All Other Contract Terms Remain the Same.**

Except as modified by this Amendment, the CONTRACT shall remain the same.
