Recommended Actions:

That the Board of Supervisors, acting as the governing authority of County Service Area 12:

- a) Accept the easement deed from Alexander Weiliang Fang and Casey Brianne Fang, trustees of the Fang Family trust and owner of APN 023-161-017, and authorize the Clerk of the Board to execute the certificate of acceptance; and
- b) Find that the proposed action does not constitute a "Project" within the meaning of the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15378(b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

Summary Text:

This item is on the agenda to acquire a public sewer easement over APN 023-101-024 to serve County Service Area 12 in the Mission Canyon area.

Discussion:

This action accepts a replacement easement over APN 023-101-024 in order to correct an error in the original easement that resulted in an encroachment by the owner who built a home improvement project in the County's 10-foot sewer easement.

Background:

County Service Area (CSA) 12 was formed to address failing septic systems in response to Regional Water Quality Control Board (RWQCB) Resolution 83-04. The County of Santa Barbara initiated the establishment of CSA 12 by Resolution 84-72, and the Santa Barbara Local Area Formation Commission (LAFCO) formally established CSA 12 by approving LAFCO Resolution 84-654. The primary function of CSA 12 is to collect wastewater via approximately 13.4 miles of sewer system, which is conveyed to and treated by the City of Santa Barbara pursuant to the terms of a joint powers agreement. The rules and regulations regarding the function and operation of CSA 12 were codified by Ordinance 3574 in Chapter 22A of the County Code. An Environmental Impact Report (EIR) was prepared for the Mission Canyon Area Wastewater Facilities Plan in November of 1983, and construction of the original sewer system was completed in 1985. The sewer system is regulated by the State Water Resources Control Board under Order No. 2006-0003-DWQ, *Statewide General Waste Discharge Requirements for Sanitary Sewer Systems*.

The sewer system project focused primarily on connecting developed parcels in the immediate vicinity of Foothill Road, based on smaller lot sizes and access. Most of the sewer system is located in public road rights of way, however, due to the hilly terrain, many sewer easements were acquired on private property to allow as many plots as possible to be served by gravity sewers, rather than pressurized systems. The sewer easement located at 887 Cheltenham Road (APN 023-161-017), contained a conflicting boundary call that resulted in an encroachment into the easement (recorded instrument no. 1985-0017601) by the owner during a home improvement project. The original easement was intended to be 10 feet wide; however, it has been determined that a 7-foot width is sufficient and avoids interference with the owner's subsequent land improvements.

Staff recommends accepting a new easement, which revises the sewer right of way from 10 feet to 7 feet in width. The original 10 foot easement will be quitclaimed to the property owner simultaneously with the recordation of the replacement easement. Staff recommends this action in order to resolve the conflicting boundary call and maintain an appropriate easement.

Performance Measure:

This action will provide the appropriate sewer rights of way to ensure the sewer main is property maintained by CSA 12.
