### CERTIFICATE OF FACTS BY COUNTY CLERK-RECORDER-ASSESSOR REGARDING APPOINTMENT IN LIEU PROCEDURES FOR SPECIAL DISTRICT OFFICES

I, Joseph E. Holland, County Clerk-Recorder-Assessor, County of Santa Barbara, DO HEREBY CERTIFY THE FOLLOWING FACTS:

By 5 p.m. on the 83rd day prior to the day fixed for the general district election:

- (1) only one person has filed a declaration of candidacy for an elective office to be filled at that election,
- (2) in the case of directors to be elected from the district at large, the number of persons who have filed a declaration of candidacy for director at large does not exceed the number of offices of director at large to be filled at that election,
- (3) in the case of directors who must reside in a division and are elected by division, the number of candidates for director at large from a division does not exceed the number required to be elected director at large while residing in that division,
- (4) and a petition requesting that the election be held was not presented to this office.

Therefore, per Elections Code Section 10515(a) I hereby request that the Board of Supervisors, at a regular or special meeting held prior to the Monday before the first Friday in December in which the election is held, appoint to the office or offices the person or persons below who have filed declarations of candidacy:
