#### 1. PROBLEM STATEMENT

The Santa Barbara Sheriff's Office performs traffic enforcement activities in four cities within the Santa Barbara County, specifically Goleta, Carpinteria, Buellton and Solvang. This traffic enforcement includes responding to, investigating, and writing reports for traffic crashes. Between the four contract cities, the department writes over 500 traffic crashes reports a year, with the City of Goleta being the largest and generating the most reports (typically about 350 a year). The City of Goleta is also the largest populated of the four, being at nearly 30,000. The City of Goleta is heavily traveled due to the Santa Barbara Airport, the University of California Santa Barbara, and the Santa Barbara City College. The other three cities are smaller but have a significant amount of tourist traffic throughout the year.

Through an OTS grant in 2023, the Sheriff's Office purchased software/equipment to write/transmit crash reports electronically and issue citations electronically. The crashes and citation data is currently processed into our RMS system, but the statistical data is minimal for the Traffic Unit to determine where crash or violator problem areas are within our jurisdiction. The software purchased has an additional program that would allow for the required statistical data review in GIS mapping or other various reports.

Also, during traffic enforcement and crash investigations throughout the county deputies are tasked with towing vehicles. This process involves handwriting a paper tow form (CHP180), of which then copies are provided to the tow company, the registered owner, and the legal owner. The information on the tow form is usually the same information that has already been captured on a citation or crash form and further extends the time a deputy is required to remain on scene of the incident. Handwriting this CHP180 form leads to the possibility of errors, legibility issues and duplication of information. This department tows an average of about 1,000 vehicles each year.
