RECOMMENDATIONS:

C.A.	Recommendation:

That the Board of Supervisors adopt a resolution establishing angle parking zones on Orcutt Road in the Orcutt Area.

ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal #5: Maintain and enhance the quality of life for all residents.

EXECUTIVE SUMMARY AND DISCUSSION

Orcutt Road is classified as a minor rural roadway, which runs north\south in front of Waller Park. The portion that runs in front of Waller Park is scheduled to be widened this fiscal year 2004-2005, which will allow angle parking to be established. The Parks Department has requested that this portion of Orcutt Road be designated as an angle parking zone. In response, the Traffic Section has reviewed a new striping plan for this portion of Orcutt Road. This new plan contains angle parking and will increase the number of vehicles that can park on Orcutt Road in front of the park. In accordance with this new pavement-marking plan, the Public Works Department recommends the establishment of an angle parking zone at the following location:

On the west side of Orcutt Road from a point 579 feet south of the centerline of Waller Lane to a point 1,318 feet south of Waller Lane.
