This Second Amendment, dated December 13, 2022 (the "Effective Date"), is made and entered into by and between the County of Santa Barbara, a political subdivision of the State of California (COUNTY), and Santa Barbara Neighborhood Clinics, a California nonprofit public benefit corporation (SUBRECIPIENT) and is made with reference to the following:

Recitals

WHEREAS:

1. COUNTY and SUBRECIPIENT entered into an Agreement (AGREEMENT), dated December 7, 2021, pursuant to the Community Development Block Grant program (CDBG) from the United States Department of Housing and Urban Development (HUD) under Title I of the Housing and Community Development Act of 1974, as amended (HCD Act), Public Law 93-383 (42 U.S.C. §§ 5301 et seq.); and the regulations promulgated thereunder (24 CFR Part 570) ("Regulations") providing \$22,763 to carry out abandonment of an existing septic system, public sewage facility tie-in, and planning and related activities pursuant to these work items (PROJECT) as more specifically described in Exhibit A Scope of Work thereto; and
2. On June 16, 2022, the parties entered into a First Amendment to extend the term of the AGREEMENT until December 31, 2022; and
3. On May 3, 2022, the Board of Supervisors approved additional CDBG funding for PROJECT in the amount of \$365,128 as a part of the FY 2022 Annual Action Plan; and
4. The PROJECT is currently under implementation but will not be completed by December 31, 2022; and
5. COUNTY and SUBRECIPIENT desire to extend the term of the AGREEMENT until December 31, 2023.

NOW THEREFORE:

1. In accordance with Section I.E. of the AGREEMENT, the AGREEMENT is hereby amended to extend the term of AGREEMENT to end on December 31, 2023.
2. Section I.B. of the AGREEMENT is hereby amended by replacing Section I.B. of the AGREEMENT to read in its entirety as follows:

“Statement of Work

Under this Agreement, SUBRECIPIENT shall perform the work described in the Statement of Work in Exhibit A (“Project”), and shall invoice the County for reimbursement of expenses incurred by SUBRECIPIENT in connection with such work to the extent such expenses qualify as eligible expenses under the CDBG Program. SUBRECIPIENT certifies that the Project meets one of the criteria set forth in 24 CFR 570.208. The Statement of Work in Exhibit A includes activities eligible under the CDBG program. SUBRECIPIENT shall be responsible for performing the work stated and set out in the Statement of Work and carrying out the Project in a manner satisfactory to the COUNTY and consistent with all federal requirements and standards required as a condition of providing these CDBG Funds. SUBRECIPIENT agrees that it will not begin work, including, but not limited to, soliciting project bids or engaging site studies, before COUNTY has issued to SUBRECIPIENT a written Notice to Proceed for the Project.”

3. Exhibit A to the AGREEMENT is hereby amended by replacing Exhibit A in its entirety with Exhibit A, attached hereto and incorporated herein by reference.
4. Exhibit B to the AGREEMENT is hereby amended to the AGREEMENT is hereby amended by replacing Exhibit B in its entirety with Exhibit B, attached hereto and incorporated herein by reference.

Except as set forth herein, this SECOND AMENDMENT TO AGREEMENT shall not modify or change any of the provisions of the AGREEMENT, and the parties to the AGREEMENT shall continue to be bound by its provisions, as amended herein.

This Amendment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.

- 3) Adding infrastructure in accordance with project drawings, plans and specifications, to enable the Clinic to tie-in to the existing public sewage facility in the adjacent roadway in the public right-of-way at the corner Kellogg Street and Calle Real in the city of Goleta;
- 4) Any such additional work that may be required to accomplish work items identified in numbers 2-3 above.

Goals and Community Impact

The improvement work that this project will provide to the Clinic will enhance sewage system reliability, increase environmental sustainability, and allow for increased utilization capacity for

the Clinic's operations. This will result in an increased quality of service provided to the Clinic's low-income clients.
