Recommendation(s):

That the Board of Supervisors approve the attached resolution approving a grant application to the California Integrated Waste Management Board for the installation of waste tire playground covering for the play area within Calle Barquero Open Space.

Alignment with Board Strategic Plan: The recommendation is primarily aligned with Goal No. 5.A High Quality of Life for All Residents.

Executive Summary and Discussion:

The California Integrated Waste Management Board is currently accepting applications for the installation of playground cover surfacing in public park playgrounds using recycled waste tire materials and to assist public agencies in meeting state and federal accessibility standards relating to public playgrounds. County Parks is proposing to submit an application not to exceed \$25,000 for the installation of playground surfacing for Calle Barquero Open Space. This park has been chosen due to its high probability to meet the general guidelines under the grant program. The total project cost is estimated at \$34,425. A 50% match of grant funds, \$12,500, will be provided as required as part of the grant application process, in the form of in-kind labor and a portion of fiscal year 2003-04 General Fund Deferred Maintenance Funds allocated to this project.

Mandates and Service Levels: No mandates or impacts to service levels with this action.

WHEREAS, the California Integrated Waste Management Board has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing program applications; and

WHEREAS, said procedures established by the California Integrated Waste Management Board require the applicant to certify by resolution approval of the application before submission of said application to the State; and

WHEREAS, if awarded a grant, Santa Barbara County will enter into an agreement with the State of California for development of the project;

NOW, THEREFORE, BE IT RESOLVED that the Santa Barbara County Board of Supervisors hereby:

Authorizes the submittal of an application to the California Integrated Waste Management Board for a Waste Tire Playground Cover Grant.

Authorizes and empowers the Director of Parks of Santa Barbara County to execute in the name of the County of Santa Barbara, all necessary applications for the purposes of securing grant funds
