That the Board of Supervisors:

Officially recognize employees with 10, 15, 20, 25, 30 and 35 years of service achieved in 2000 per the attached resolution adopted by your Board on March 13, 2001 and present service awards to South County employees in categories of 20 years of service and over and elected officials in categories of 10 years of service and over.

Alignment with Board Strategic Plan:

This recommendation is primarily aligned with Goal No. III. A Strong, Professionally Managed County Organization.

Executive Summary and Discussion:

On January 25, 2000 your Board reinstated its former program of recognition for employees who have provided longstanding service to the County. Employees, department heads and elected officials with 10, 15, 20, 25, 30 and 35 years of service are eligible to receive an award.

This year there are 462 employees who will receive such awards, of which 146 employees have served the County for 20, 25, 30 and 35 years, including 5 department heads and elected officials with 10 or more years service. Of these 146 long-term employees, those who attend will receive an award personally from you at one of two Board meetings to be held in Santa Maria on March 13, 2001, and Santa Barbara on

March 27, 2001. Approximately 55 employees will be personally receiving awards at the board meeting in Santa Barbara.

Receptions hosted by the Executive and Management Associations will follow the presentations in the Board Conference Rooms after the award ceremonies. The Santa Barbara ceremony will be conducted at 2:00 p.m.

The County is very fortunate to have the many employees represented on the attached resolution who have clearly demonstrated their loyalty and dedication to public service.
