Recommended Actions:

Authorize the County Purchasing Agent to sole source the purchase of a step screen and wash press from Huber Technology, Inc. (not a local vendor) in the amount of \$158,000 (plus applicable taxes).

Summary Text:

This action requests authorization to purchase a step screen and wash press to replace the old barminutors that have become outdated.

Background:

The headworks of the main plant currently utilize barminutors to shred material initially entering the treatment plant that is later removed by other processes. The barminutors have been in use since 1960 and are considered old technology and inefficient. Repair and replacement has become difficult since many parts are no longer available. Stair step screens are standard in the industry today due to improved efficiency and are better suited to handle peak flows.

While several companies manufacture step screens, Huber Technology, Inc. makes a particular model that will minimize the retrofit necessary to the existing influent building resulting in a reduced cost for installation. Similar screens manufactured by other vendors are approximately the same cost. In

addition, a second screen of the same make and model can be used in the future to accommodate plant expansions.

Replacement of the barminutors with this step screen will reduce repair costs and help the plant run more efficiently.

Narrative: The replacement of the barminutors was included in the 2007/2008 fiscal year budget. Additional budgeted costs are taxes, design of modifications to the influent building, and installation. Funding for the purchase is derived from reserves for capital replacement. Annual operational costs are not expected to change since the project replaces existing equipment. Maintenance costs are expected to be reduced.
