Justification: If awarded will authorize the Sheriff to execute the FY2020 Edward Byrne Memorial Justice Assistance Grant (JAG) agreement with the United States Department of Justice (USDOJ). Santa Barbara County will be awarded \$88,358 and will use the funds for acquiring, upgrading and maintaining equipment and training for the Santa Barbara Countywide Bomb Squad: \$65,000 capital equipment - 2021 F450 Truck; \$4,928 various explosives and ammunition for rendering safe procedures; \$14,930 mandated bomb squad training/certification; \$3,500 National incident-based reporting system training.
