SUPERVISOR LINDA PARKS, DISTRICT 2 VENTURA COUNTY BOARD OF SUPERVISORS

Supervisor Parks is presently the Chair of the Ventura County Board of Supervisors. She previously served as Mayor of the City of Thousand Oaks and was a member of the City Council for six years and a Planning Commissioner for four years. As a city official, she sponsored the "Parks Initiative" that preserves open space and parkland in Thousand Oaks, wrote the City's first campaign reform law, founded the Ventura County Discovery Center, created the City's Resident's Roundtable, and initiated the annual Thousand Oaks Earth Day/Arbor Day Celebration planting a 1,000 oaks in Thousand Oaks. She is one of the organizing directors of the countywide SOAR campaign, which was successful in creating a law to protect open space and farmland in addition to establishing urban boundary limits around County cities. Recently, Ms. Parks' sixteen-year grassroots effort to preserve Ahmanson Ranch culminated in the Ranch's purchase as a State Park. As a Ventura County Supervisor, Ms. Parks continues to champion quality of life issues, setting policy on the Board of Supervisors, the Santa Monica Mountains Conservancy, LAFCO, the Air Pollution Control District, Ventura Council of Governments, California State University at Channel Islands Site Authority, the County Mental Health Board, the County Disaster Council, and the Ventura County Transportation Commission.

Ms. Parks' recent accomplishments include organizing a County-wide Senior Summit to plan for the services that will be needed for the growing senior population. She has also taken a leadership role in establishing a County transportation vision to provide an alternative to a future of congested roadways, and has been a strong proponent of public safety, hosting several public safety town halls and establishing fire safe councils. She also developed County guidelines that require testing water and soil near the Boeing Santa Susana Field Laboratory where perchlorate and TCE have been found.



Jon Sharkey is in his second term as a member of the Port Hueneme City Council, having been re-elected without opposition. He served as mayor during the city's fiftieth anniversary year in 1998. Council Member Sharkey led the fight against the infamous "view tax", was instrumental in writing and passing Port Hueneme's city charter, and saved Shady the city hall cat from eviction. He is Past Chair of the Ventura Regional Sanitation District, and is a Director of the Beach Erosion Authority (BEACON). Jon is a 1971 graduate of the University of Massachusetts, Amherst. He is married to Dr. Beverly Kelley, professor of communications at California Lutheran University, columnist for the Ventura County Star.

Mayor, City of Port Hueneme: Elected 1994. Re-elected without opposition 1998

Accomplishments:

- Helped to write and pass city charter for Port Hueneme
- Led campaign for voter approved utility tax providing stable funding for police department
- Negotiated agreement with Coastal Commission for resource protection zone
- Helped to institute first time home buyer's assistance program bringing the American Dream within reach of many who otherwise would be left out
- Led repeal of infamous "view tax"
- Rationalized street sweeping schedule in the city
- As Mayor, presided over city's successful 50th anniversary celebration
- Oversaw implementation of community policing program resulting an a 20% drop in the city's crime rate
- Negotiated settlement agreement between Regional Sanitation District and Santa Clara School District
- Took leadership role in obtaining permits for Toland Road Regional Landfill by testifying before State Water Quality Board and local permitting authorities
- Mediated dispute between Channel Islands Beach Community Services District and US Navy regarding testing issues
- Participated in successful negotiations for new revenue sharing agreement between the city and the Oxnard Harbor District
- Campaigned for Beach Restoration and Enhancement Act, testified before Assembly Natural Resources Committee
- Helped to lead CalCoast's "Beach Awareness Day" at State Capitol by lobbying members of the legislature in regard to beach erosion issues
- Helped to organize "Citizenship Day" in Oxnard which processed over 1500 applicants for new citizenship
- Led effort to reorganize county library system in the face of severe budget shortfall
- Oversaw construction of \$26 million water project which provided a stable source of quality water for the next generation of residents
- Founded the prestigious Sustainability Council of Ventura County, a nonprofit corporation educating the public on issues regarding long term quality of life and
- Saved "Shady," the city hall cat, from the threat of eviction
