SUBJECT: Roads General Fund Designations for Fiscal Year 2004/2005

All Supervisorial Districts

Recommendation(s):

A. Receive a report on the use of Roads General Fund Designations for Fiscal Year 2004/2005;

- B. Direct staff to utilize the existing Roads General Fund Designations for Fiscal Year 2004/2005 in the amount of \$268,000 to supplement the Road Maintenance Annual Plan (RdMap) approved surface treatment program (contracts/county forces);
- C. Approve the use of County Forces to complete the Construction of 2004/2005 Measure "D" Preventive Maintenance Application of Fog Seal Coat in the 1st, 2nd, 3rd and 4th Supervisorial Districts, County Project No. 820515 in accordance with Section 20395 (c) of the California Public Contract Code.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

Recently the Department has requested construction bids from the contracting community for various surface treatment projects throughout the County of Santa Barbara. Unfortunately, the bids received were higher than the budgeted amount in the Fiscal Year 2004/2005 Road Maintenance Annual Plan and in one project from Fiscal Year 2003/2004.

As your Board knows, the County's primary pavement surface treatment strategies are all based on the use of oil. Staff and the industry define the strategies employed as a preventive maintenance program and these operations here in Santa Barbara County typically take the form of Fog Seals, Slurry Seals and Asphalt Overlays. At times, we will also program the recycle or the reconstruction of roadways in our RdMap because the use of corrective maintenance is no longer a viable option and the condition of the roadway must be addressed. Also, prior to an asphalt overlay being performed, staff must repair the concrete improvements

that have been damaged in our urbanized communities. These concrete improvements take the form of removal and replacement of damaged sidewalk, curbs, gutters and driveway aprons. We are also mandated by the Americans with Disabilities Act to make our sidewalks accessible; this work is included as well.

There has been a reported sharp increase in costs associated with asphalt material and oil over the course of the last year. This not only impacts the costs of the surface treatment planned for roadways, but all transportation costs to get the material to the site. The County's Public Works Department creates the RdMap on an annual basis to define how staff plans to perform road maintenance activities, both preventive and corrective, with the limited transportation funding available. In a typical year the RdMap process commences just after the new year in January. At that time preventive maintenance projects begin to take form and estimates to complete the various surface treatments are determined. From January to August of 2004 Caltrans reported that oil costs had increased over 37 %. The County recently opened two bids; one for a Fog Seal Coat and one for an Asphalt Rubber Aggregate Membrane (ARAM), which on average exceeded the Engineer's Estimate by 28%.

The following table shows the projected difference from the contract budgeted amounts and the bid amounts received from contractors for the ARAM and the Fog Seal Coat contracts:

The Department believes that four viable options exist for your Board to consider at this point for the County to move forward with the programmed surface treatment of the roads included within these contracts:

Option 1: Direct staff to perform the Fog Seal Coat utilizing county Maintenance forces and to utilize Roads General Fund Designations for Fiscal Year 2004/2005 in the amount of \$268,000 to supplement the Road Maintenance Annual Plan (RdMap) for approved surface treatment program (contracts/county forces). This will allow the Department to complete the scope of the project included in the 2004/2005 Measure "D" Preventive Maintenance Application of Fog Seal Coat. Due to the increase in oil costs to date, an additional \$40,000 above the budgeted project is required to perform the Fog Seal Coat. However, a potential savings to the County of approximately \$224,000 for Fog Seal Coat will be realized. This option also allows for the ARAM contract to proceed as programmed within the FY 2003/2004 RdMap.

Option 2: Reduce the scope of the approved surface treatment program from the FY 2004/2005 RdMap and the ARAM project from FY 2003/2004. This would entail meeting with each of your offices to prioritize the removal of roads from the currently approved list of streets within these documents (Attachment #'s 1 & 2). Upon completion of that prioritization process staff would then return to your Board for approval of this reduction.

Option 3: Defer these contracts to the FY 05/06 RdMap process where additional funding could be programmed to augment the FY 2004/2005 RdMap and the ARAM project from FY 2003/2004. If this option were chosen there is a chance that oil prices will continue to rise and today's project cost overruns could be greater a year from now.

Option 4: Over the past fiscal years your Board has made General Fund monies available to address the deteriorating Transportation Infrastructure System. In the FY 2004/2005 County Budget process \$500,000 in Roads General Fund Designations were approved for Road Maintenance purposes. This funding was also included within the Fiscal Year 2004/2005 RdMap. However, specific road repairs were not identified in light of the potential State budget ramifications to the County General Fund. This option would allow your Board to direct staff to go back out to bid with both the Fog Seal Coat and ARAM contracts. At this time the anticipated difference in cost from what was programmed is \$491,176.37. If this option were chosen, like option 3, there is a chance that oil prices will continue to rise and today's project cost overruns could be greater after the rebidding process.

Staff recommends approval of Option 1. This will allow for staff to capitalize on the remaining good weather still available this calendar year and commence the Fog Seal Coat surface treatment work almost immediately. The ARAM contract would be scheduled for readvertisement for bids in the Winter of 2005, with construction scheduled to commence Late Spring/Early Summer of the same year. The Department will more than likely combine the ARAM contract with other similar work to capitalize on economies of scale in the bidding process and to reduce the impact of rising oil costs.

The California Public Contract Code defines the application of Fog Seal Coat as maintenance; as such this work can be completed by county forces. Public Works staff has contacted other Counties throughout the State and found that local agencies are performing this type of maintenance work with their own internal county Maintenance forces as well. Section 20395 (c) of the California Public Contract Code states that, "The work may be done in any of the following ways: (c) by purchasing the material and having the work done by day labor, in which case advertising for bids is not required". As proposed, staff would contract for the supply of Fog Seal material and county maintenance forces would be responsible for sweeping the existing pavement, applying the Fog Seal material and final pavement delineation.

As your Board knows in a typical year Roads General Fund Designations are programmed to various roadway repairs within each Supervisorial District based on the current Measure "D" Distribution formula. At this time the current Measure "D" Distribution formula is one that is based on a 50/50 percentage between a District's unincorporated population and road lane miles. Staff recommends fully funding the ARAM bid difference in the amount of \$228,000 and the additional \$40,000 to complete the Fog Seal Coat with Roads General Fund Designations for Fiscal Year 2004/2005. The remaining balance of \$232,000 would then be available to distribute to each Supervisorial District based on the current Measure "D" Distribution formula:

Staff would work with your offices to select projects within each Supervisorial District for the Roads General Fund Designations remaining. Once that process was completed we would return to your Board for approval and inclusion within the FY 2004/2005 RdMap.

Mandates and Service Levels:

This action will allow the Department to provide the level of service currently programmed in the FY 2004/2005 and FY 2003/2004 RdMaps.

Fiscal and Facilities Impacts:

The use of Roads General Fund Designations for Fiscal Year 2004/2005 in the amount of \$228,000 to supplement the FY 2004/2005 RdMap and the ARAM project from FY 2003/2004 will fully fund previously approved and programmed surface treatments.
