She joined the administrative team in 2007 as a Supervising Probation Officer (SPO), and after serving in both the Juvenile and Adult divisions, she promoted to Manager in 2017; and

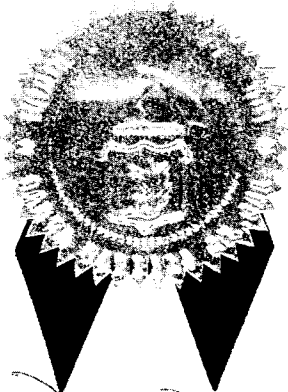
