#### **Recommendation(s):**

That the Board of Supervisors:

- A. Approve the Project and Categorical Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the 2004 STIP Countywide Road Rehabilitation Program in All the Supervisorial Districts; County Project No. 810524.
- B. Authorize the Director of Public Works to advertise for construction bids for the 2004 STIP Countywide Road Rehabilitation Program in All the Supervisorial Districts; County Project No. 810524.

### Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Strategic Plan Goal Number 1: An Efficient Government Able to Respond Effectively to the Needs of the Community.

### **Executive Summary and Discussion:**

This Countywide project represents the resurfacing of approximately 29 lane miles of structurally deficient Federal Aid routes and will also address shoulder restoration, repair of damaged curb, gutter and sidewalk, installation of curb ramps where required and replacement or repair of deteriorated drainage facilities.

Pursuant to the County's CEQA guidelines, the project has been determined to be exempt from further environmental review. Approval of this Categorical Exemption will indicate the Board of Supervisors' approval of this project and will commence the appeal period, pursuant to CEQA guidelines.

The Department is in the process of submitting a funding allocation request for preliminary engineering to the California Transportation Commission, we anticipate being placed on a pending allocation list and to receive funds in the next two years.

The "Notice to Contractors" will be published prior to the date set for the opening of bids.

Sealed proposals will be received at the Public Works front counter in the County Engineering Building, 123 E. Anapamu Street, Santa Barbara, California 93101, and at the North County Public Works office, located at 620 West Foster Road, Santa Maria, California, and will be opened publicly and read aloud at a date to be determined.

The project was included in the 2002 Regional Transportation Plan and was included in the FY 05/06 Capital Improvement Plan.



### **Mandates and Service Levels:**

Approval by the Board of Supervisors will not change the programs or service levels.

### **Fiscal and Facilities Impacts:**

The funding for the project is provided by the Federal Surface Transportation Program (88.53%) and the State Transportation Improvement Program (11.47%).

Funds have been budgeted in Dept. 054, Fund 0015, Program 2900, Org 0022, and Account 7510.
