STEMI RECEIVING CENTER DESIGNATION

THIS IS THE EIGHTH AMENDMENT (hereafter referred to as Eighth Amendment) to the Agreement for STEMI Receiving Center Designation, by and between the County of Santa Barbara (COUNTY) and Santa Barbara Cottage Hospital (HOSPITAL), commencing on January 1, 2023 (the "Agreement").

WHEREAS, the Agreement is effective through December 31, 2022; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, this Eighth Amendment incorporates the terms and conditions set forth in the Agreement, First Amendment, Second Amendment, Third Amendment, Fourth Amendment, Fifth Amendment, Sixth Amendment, and Seventh Amendment approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this Eighth Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. Amendments.

- a. The Agreement is amended as follows:
 - 4. **TERM.** The term of this Agreement shall be for the period of January 1, 2023 through December 31, 2023.
 - 5. **FEES.** HOSPITAL agrees to pay COUNTY for services provided under the terms of this Agreement: **\$32,463** for the extended one-year term for maintaining the STEMI program. This service charge shall be paid in full by January 31, 2023.
- 3. <u>Counterparts.</u> This Eighth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. <u>Effectiveness of Agreement.</u> Any and all other terms and provisions of the Agreement, as amended, remain in full force and effect.
