Recommended Actions:

That the Board of Supervisors consider the following recommendations:

- a) Approve and ratify an Emergency Memorandum of Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from September 1, 2020 through September 30, 2020 for an amount not to exceed \$23,000; and
- b) Approve and ratify a First Amendment to the Emergency Memorandum of Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from October 1, 2020 through November 1, 2020 for an amount not to exceed \$29,000; and
- c) Approve and ratify an Emergency Memorandum of Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from November 2, 2020 through May 1, 2021 for an amount not to exceed \$201,000; and

- d) Approve and ratify an Emergency Memorandum of Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from May 1, 2021 through October 1, 2021 for an amount not to exceed \$116,000; and
- e) Approve, ratify, and authorize the Chair to execute an Emergency Memorandum of Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from October 1, 2021 through December 31, 2021 for an amount not to exceed \$100,000; and
- f) Approve and ratify a Temporary Right of Entry Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from September 1, 2020 through November 1, 2020; and
- g) Approve and ratify a Temporary Right of Entry Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from November 2, 2020 through May 1, 2021; and
- h) Approve and ratify a Temporary Right of Entry Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from May 1, 2021 through October 1, 2021; and
- i) Approve, ratify and authorize the Chair to execute a Temporary Right of Entry Agreement between the County of Santa Barbara and Goleta Valley Community Center located in Southern Santa Barbara County to assist with emergency management services in connection with the COVID-19 INCIDENT, including but not limited to testing and vaccinations from October 1, 2021 through December 31, 2021; and
- j) Determine that the recommended actions are not the acceptance and approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the project is a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment; and that the actions are exempt from CEQA pursuant to Guidelines Section 15269(c) as they consist of specific actions necessary to prevent or mitigate an emergency.

Summary Text:

This item is on the agenda for your Board to approve and ratify the Emergency Memorandum of Agreements (MOA) and Temporary Right of Entry Agreements (TROE) with Goleta Valley Community Center (GVCC) during the period of September 1, 2020 through October 1, 2021 for the provisions of community COVID-19 testing and vaccinations as part of the County's COVID-19 response efforts (Attachments A-D and F-H); and to approve, ratify, and execute an MOA and TROE for continued community testing and vaccinations for the additional period of October 1, 2021 through December 31, 2021 (Attachments E and I).

Background:

On March 12, 2020, the Board of Supervisors declared a local emergency proclamation in response to the COVID-19 pandemic. As part of the County’s response to stop the spread of the Coronavirus, the County used its emergency contract authority to execute MOAs for Mutual Aid and TROEs with the GVCC to provide community COVID-19 testing and vaccinations. The agreements for the period of September 1, 2020 through October 1, 2021 were executed pursuant to the Director of Emergency Services’ authority under County Code Chapter 12.

Thus, the request is for your Board to approve and ratify the Emergency MOAs and TROEs with the GVCC for the period of September 1, 2020 through October 1, 2021, and to approve, ratify, and execute the MOA and TROE for the additional period of October 1, 2021 through December 31, 2021, for site use for community COVID-19 testing and vaccinations as part of the County’s COVID-19 response and mitigation efforts.

Based on incurred rental usage and services, it is anticipated that the Public Health Department may expend up to \$279,500, as a not to exceed, during FY 2020-21 and \$189,500 during FY2021-22 on COVID-19 testing at these sites. Costs associated with this Agreement will be funded through federal funds received from the Federal Coronavirus Response and Relief Supplemental Appropriations Act of 2021, P.L. 116-260.
